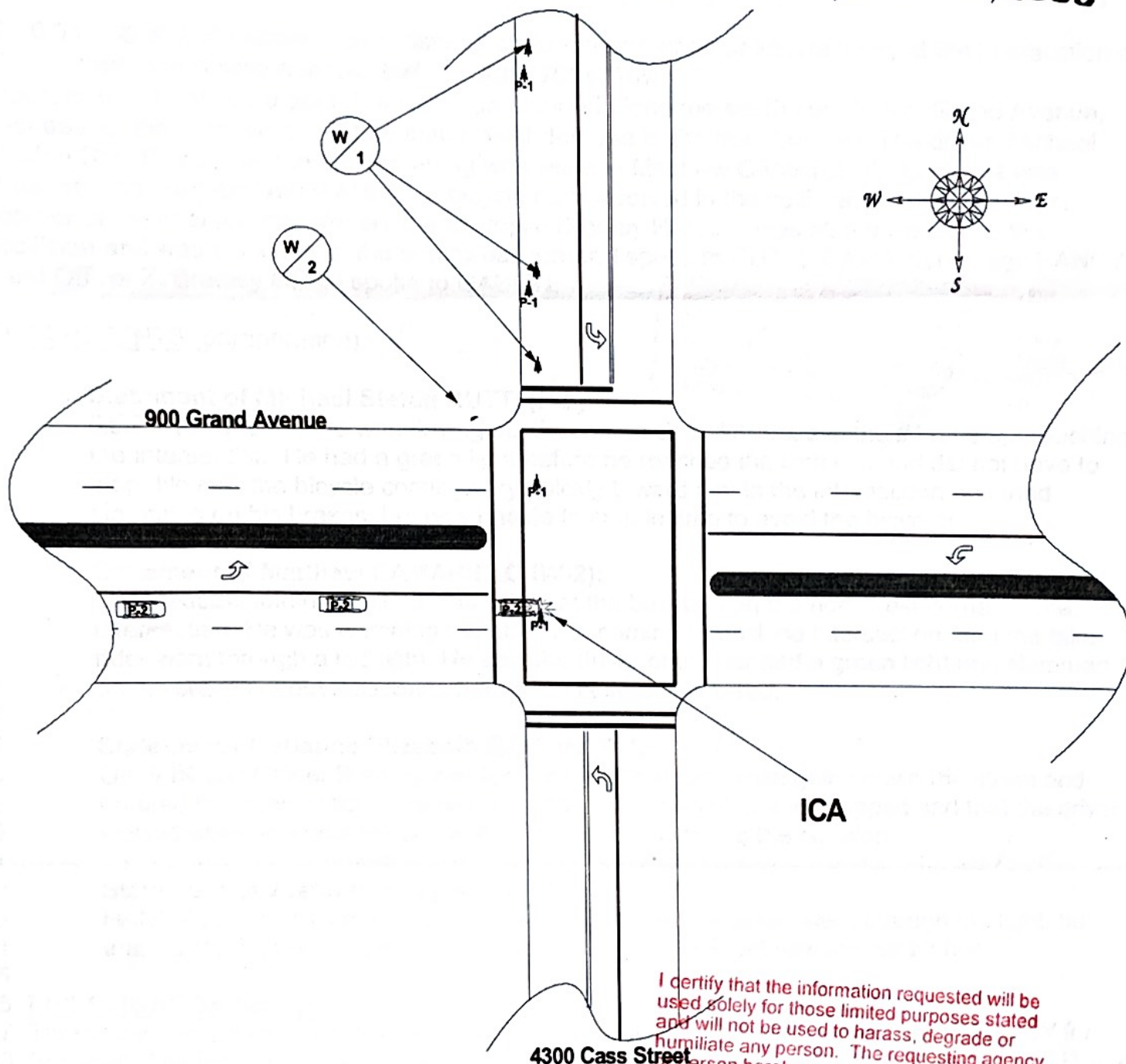

905995**1 COLLISION INVESTIGATION:**

2

3 On 07/18/09 at 2043 hours, I was dispatched to a report of an unknown injury at the intersection of
4 Cass Street and Grand Avenue, incident #09070040107.

5 Upon arrival, I noticed a gold Saturn sedan stopped along the south curb-line of Grand Avenue,
6 just east of the intersection. It had minor paint damage to the front bumper. The driver, Michael
7 Stefan RUTTI, was next to his car, along with witness Matthew CAMARILLO. Medic 24 was
8 treating Brianne Elizabeth GAULIN, a bicycle rider involved in the collision, on the southwest
9 corner of the intersection. Her boyfriend, Justin Bradley HANCY, was also a witness to this
10 collision and was standing on the southwest corner. I spoke to RUTTI, CAMARILLO, and HANCY,
11 and Officer Z. Bradley #6526 spoke to GAULIN.

13 STATEMENTS (paraphrased):

14

15 Statement of Michael Stefan RUTTI (P-2):

16 RUTTI told me that he was driving eastbound on Grand Avenue in the #1 lane approaching
17 the intersection. He had a green light before he reached the limit line and did not have to
18 stop. He saw the bicycle coming very quickly toward him in the intersection and tried
19 slamming on his brakes, but was unable to stop in time to avoid the bicyclist.

21 Statement of Matthew CAMARILLO (W-2):

22 CAMARILLO told me that he was sitting at the bus stop on the northwest corner of the
23 intersection. He was watching the bicyclists coming toward the intersection, and the bike
24 rider went through a red light. He said the driver of the car had a green light and slammed
25 on his brakes about 2 seconds before the collision occurred.

27 Statement of Brianne Elizabeth GAULIN (P-1):

28 GAULIN told Officer Bradley that she had a yellow light while going down the street and
29 entered the intersection. She said the other car that hit her was stopped and that the driver
30 started when she was already in the intersection, causing the collision.

31

32 Statement of Justin Bradley HANCY (W-1):

33 HANCY told me that the signal light was yellow when Brianne went through the light, but
34 that he stopped. He did not see the light change to red, but saw the car hit her.

35

36 INVESTIGATION (con't):

37 There was minor damage to the rear wheel of the bicycle, which was turned over to HANCY for
38 transport. The bicycle did have a red reflector to the rear, and white reflectors in the wheels. IT did
39 not have a forward facing white light, as required by section 21201(a) CVC.

40 GAULIN was transported to UCSD Thornton Hospital with a bloody lip, cut chin, and loose teeth.

2 P-1 GAULIN was traveling south on Cass Street approaching Grand Avenue and did not stop at
3 the limit line for a red light, a violation of 21453(a) CVC. P-2 RUTTI was eastbound on Grand
4 Avenue approaching Cass Street, was unable to see the bicycle, and proceeded through the
5 intersection on a green light.
